NOTICE:

CONCEALED HANDGUN CARRY APPLICANTS

Effective December 19th, 2017, by Order of the Ohio Attorney General (Opinion 2017-045), the Perry County Sheriff shall not issue a concealed handgun license pursuant to RC 2923.125 to a person who is **not** eligible under **Federal** law to receive or possess a firearm. **All** applicable **Ohio** laws, as stated on the Application Form, remain in full force and effect.

Qualifying/Disqualifying Factors:

With regard to the State of Ohio Application for License to Conceal Carry a Concealed Handgun, it is the intention of the Ohio Legislature that this Law (RC 2923.15) is compliant with the National Instant Criminal Background check system. This system of checks contains disqualifiers **not** specifically enumerated in Section III and/or IV of the license Application. **If a disqualifier is found, your application will be denied.**

Age: 21 years or older

Residency: Legal Resident of United States & Ohio resident in county of application or adjoining county, or resident of another state employed in county of application or adjoining county (employment proof required; current paystub or employer letter.

Training: Completion of an 8 hour (or more) certified firearm program (must present certificate with application within 3 years of course completion) UNLESS waived because of previous military service (honorable discharge) within past 10 years or proof of Ohio Peace Officer Training Academy Certificate within past 10 years.
